Terms & Conditions/Disclaimer

1. I have sufficient skiing or snowboarding skills in order to use this training center.
2. I understand that the training activities involve a degree of risk.
3. I understand that a valid ski/training ticket is required to use this this training center.
4. I will always listen to the staff's instructions and remarks. If I refuse to follow this rule I may not be permitted to use this training center.
5. People under the influence of drugs or alcohol may not use this training center.
6. I have checked my equipment which is in good working order, properly maintained and suitable for the training.
7. I will check the edges of my board/skis before every jump on the airbag. If the edges of my board/skis are damaged I will repair them before the jump or stop my training on the bag immediately.
8. The user has to make sure that the airbag is not damaged or ripped in any way BEFORE using the airbag (that is, before the first jump of the day). With the first jump into the airbag the user declares that the airbag is in excellent condition and that he/she accepts the principle of reversal of evidence. In case of a defect, the user has to prove that it was not him/her but a third party who is responsible for the defect. It is the user's responsibility to report the damage to Murtal Seilbahnen immediately. When noticing a defect, the user can no longer train with the airbag until Murtal Seilbahnen officially approve again.
9. The user is not permitted to allow access to the airbag to third parties during his/her practice. The user is liable for third parties' damages.
10. If I cause damage to anyone else or their property, I will take the blame and I will make sure that Murtal Seilbahnen Betriebs GmbH or any of its related companies will not incur any damage in this regard.
11. I will always be aware that the slope/kicker/landing area is clear of other persons before I make my jump.
12. I am in possession of a valid personal liability insurance and personal accident insurance that cover my training activities.
13. However, I confirm that Murtal Seilbahnen Betriebs GmbH is not to blame in any way if I get injured.

14. Murtal Seilbahnen Betriebs GmbH will be entitled to capture and use audio recordings, video recordings and photographs from the training and to use my image, appearance, performance material for any purpose (be it commercial, promotional or otherwise) in all media, forever.
15. Murtal Seilbahnen Betriebs GmbH will be enabled to use, broadcast, screen, display, reproduce and/or make available to the public the material in any and all media, including but not limited to radio, television, cinemas, events, data carriers and the worldwide web. I know that I won't have the right to approve any of the material.
16. I acknowledge that a ticket is valid for 4 hours minimum/day.
17. I acknowledge that there will be no refund on the lift/training ticket in case of bad weather or visibility conditions.
18. I respect and follow the COVID-19 rules that apply in Austria. Wearing a mask (FFP2), keeping distance and disinfection of your hands is mandatory!
19. If you feel any COVID-19 symptoms, inform our staff immediately and don't use our facility. Austrian COVID-hotline: call 1450!
20. Place of jurisdiction is Austria, 8861 St. Georgen.
Austrian laws apply between the user and Murtal Seilbahnen.
21. When signing this document, the user (name/names listed below) agrees to the conclusion of a contract with Murtal Seilbahnen. The user will be made responsible for his/her violation of the contract. He/She provides credit card details to vouch for possible damages which have to be paid immediately (security deposit without verification).
